## FAMILY and PERSONAL HEALTH - NURSING (cont.)

### IMMUNIZATIONS:

1. Government provided Vaccines for Children for State required vaccines for children on Medicaid and CHIP, Alaskan Native/American Indian children, uninsured children, and children whose insurance does not fully pay (under-insured) for immunizations.

Administration fee per vaccination is \$14.52. For payment made at the time of service, administration fee per vaccination is \$14.00

2. For insurance covered vaccines, the fee will be a vaccine charge rounded up to the next dollar plus a \$25.00 administration fee per dose of the vaccine.

3. For non-insurance covered vaccines, the fee will be a vaccine charge rounded up to the next dollar plus a \$14.00 administration fee per vaccination for payment at the time of service.

4. School vaccine exemption is a \$ 25.00 administration fee.

**ENVIRONMENTAL HEALTH**

NOTE: All fees are doubled if establishment opens without a permit or if building starts without a permit for a septic system.

**FOOD SERVICE**

Definitions:

- Class 1: 1-10 seats or under 1,000 sq. ft.
- Class 2: 11-50 seats or 1,001 - 3,000 sq. ft.
- Class 3: 51-75 seats or 3,001 - 5,000 sq. ft.
- Class 4: 76 + seats or over 5,000 sq. ft.

A Seasonal Food Service Establishment is a facility that does not meet the definition of a permanent food service establishment, has a limited menu, has hard plumbing, is in one location, and does not operate more than 90 days each calendar year.

**PLAN REVIEWS:**

If request plan review within 3 business days, double the plan review fee. Food establishments that fail to complete the renewal process within 60 days will have their permit revoked. The owner/operator will need to apply and pay for a new permit.
