**Eligibility Requirements**

You may be eligible for WIC services if you:

- Are pregnant
- Had a baby less than 6 months ago
- Are breastfeeding a baby under age 1
- Have a child under age 5

Other documentation needed to qualify include:

- Identification for all who would qualify WIC
- Proof of address in Utah County
- Proof of household income
- WIC Income levels July 1, 2017-June 30, 2018
